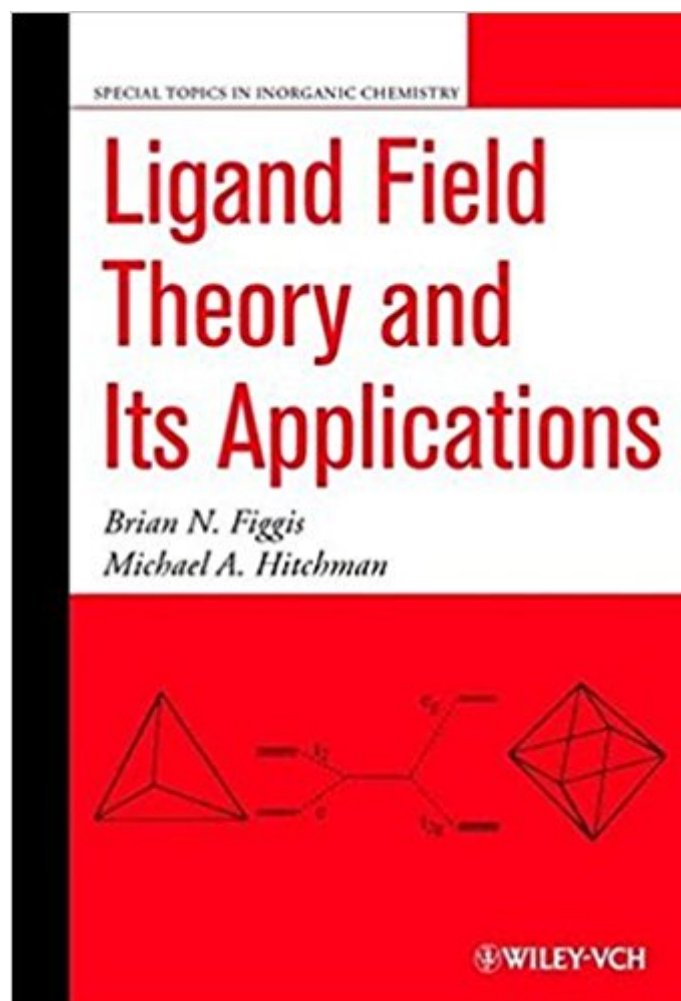

According to the preface, the book of Figgis & Hitchman is a revised and extended version of Figgis' Introduction to Ligand Fields published in 1966. The book offers a modern approach to ligand field theory (LFT) which is an extension of crystal field theory (CFT) developed in the 1930s by two giants, Bethe and Van Vleck. While CFT is concerned with the study of energy levels of single metal ions surrounded by a symmetric (octahedral, tetrahedral, etc.) arrangement of point charges, LFT includes additional effects that account for the covalent character of metal-ligand bonds. The objects

of study of LFT are the coordination complexes of transition metals which are commonly investigated in inorganic and coordination chemistry. Although nowadays it is possible to perform accurate quantum mechanical calculations on such metal complexes, LFT is still important a tool for the possibility it offers to interpret both experimental and computational results. Two books that are historically important and still useful to the inorganic chemist are Ballhausen's Introduction to Ligand Field Theory (1962) and Griffith's The Theory of Transition-Metal Ions.
