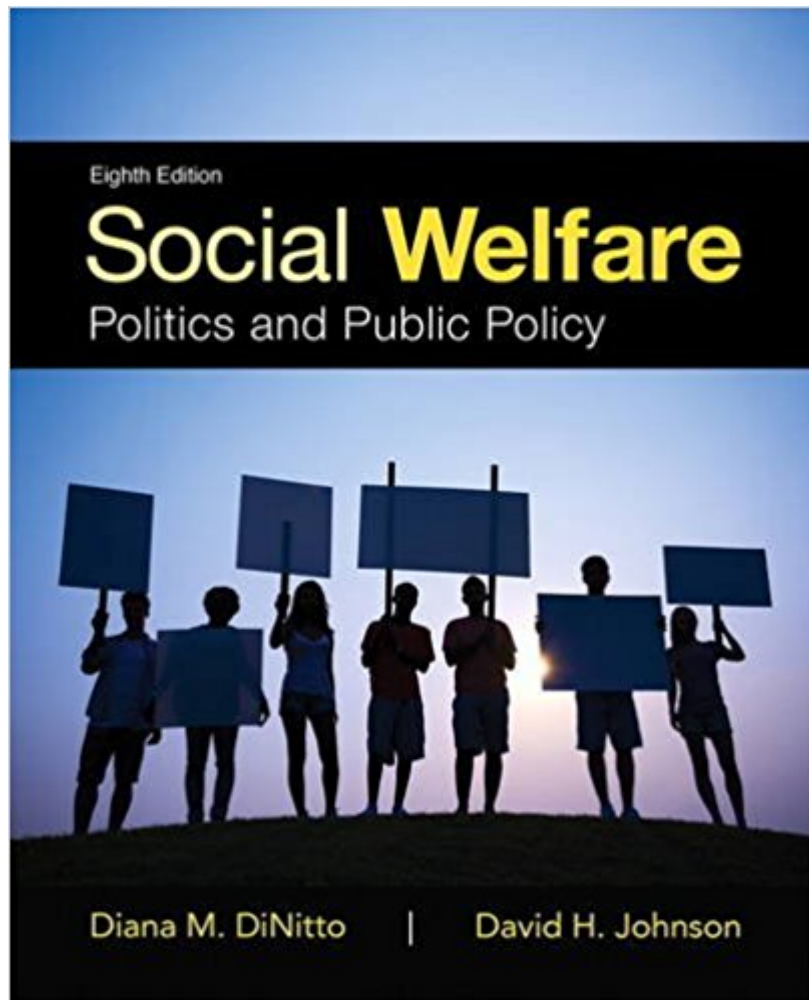

Her research is on substance abuse, violence against women, and social welfare policy. She is a Fellow of the

American Academy of Social Work and Social Welfare and serves as a member of its Social Work Grand Challenges Executive Committee. Dr. DiNitto has served on the boards of the Council and Social Work Education, the Association for Medical Education and Research on Substance Abuse, and the Texas Research Society on Alcoholism. She has been a visiting professor at the University of Hawaii at Manoa, University of Illinois at Urbana-Champaign, University of Sydney (Australia), and Tallinn University (Estonia).
